1	Dog biting an adult or child	<ul style="list-style-type: none"> • Owners are informed that there are young children in the household. • Dogs temperament towards children will be assessed at our meet & greet. • Item 2 of our terms & conditions state <i>"My dog is child friendly and has no history of aggression towards humans of any age"</i>. • Children will not be left with a dog unsupervised. 	<ul style="list-style-type: none"> • Secure the dog to prevent further incidents. • Stay calm and use distractions (toy, ball etc) to get the dog back on a lead if they aren't. • Once the dog is secured, help the injured person as much as possible. • Exchange contact details with the injured person. • Make a factual record of the circumstances and exchange contact details with any witnesses.
2	Dog being attacked by another dog / animal or attacking another dog / animal	<ul style="list-style-type: none"> • In the exercise section of our registration form we state <i>"For the safety of your dog, they will always be walked on a lead unless requested otherwise by you. In this case they must have a good temperament towards other dogs and excellent recall"</i>. • Owners will be asked about the dog's temperament towards other dogs when on / off the lead at our meet & greet. • Dogs will always be walked on a lead if around livestock or any "trigger" species 	<ul style="list-style-type: none"> • Secure the dog to prevent further incidents / injury. • Stay calm and use distractions (toy, ball etc) to get the dog back on a lead if they aren't. • Once the dog is secured, help the injured dog / animal as much as possible. • Exchange contact details with the owner of other the dog / animal. • Make a factual record of the circumstances and exchange contact details with any witnesses.
3	Dog ingests foreign object / poisonous substance	<ul style="list-style-type: none"> • In the exercise section of our registration form we state <i>"For the safety of your dog, they will always be walked on a lead unless requested otherwise by you. In this case they must have a good temperament towards other dogs and excellent recall"</i>. • Dogs history of eating foreign objects and risk of ingesting poisonous substances (mushrooms, slugs etc) will be discussed with owners at our meet and greet. 	<ul style="list-style-type: none"> • In the instance that a foreign object or suspected poisonous substance is ingested, veterinary advise / care will be sought.
4	Running loose	<ul style="list-style-type: none"> • Our back garden is fully enclosed with an access gate at either side. A secondary gate has been installed in the case that the access gate is left open. • Item 3 of our terms & conditions state <i>"My dog is fully insured, microchipped and has a dog tag detailing the owners name, address, and phone number"</i>. • In the exercise section of our registration form we state <i>"For the safety of your dog, they will always be walked on a lead unless requested otherwise by you. In this case they must have a good temperament towards other dogs and excellent recall"</i>. 	<p>In the event that a dog runs loose and cannot be found we will -</p> <ul style="list-style-type: none"> • Inform the owner • Search the local area & buildings • Seek the assistance of neighbours and fellow dog walkers • Contact local authority Dog Warden • Contact local kennels, rehoming centres & vets • Contact microchip database & DogLost • Use noticeboards, registers & social media
5	Injury or death of a dog through injury whilst in our care	<ul style="list-style-type: none"> • Our registration form has been written with the dogs best interest at heart and to mitigate such accidents from occurring. • We have risk mitigation actions in place for hazards 2, 3 & 4 of which, out with any medical conditions, pose the most threat to the wellbeing of a dog whilst in our care. • Item 7 of our terms & conditions state <i>"I authorise Barkcation Babo to call a veterinary surgeon of my behalf in the case of an emergency whereby I cannot be contacted"</i>. 	<ul style="list-style-type: none"> • Inform the owner • Seek veterinary advise / care • Inform local authority
5	Death of a dog through ill health	<ul style="list-style-type: none"> • Under the medical history / hygiene requirements section of our registration form, we specifically ask for details of any current / ongoing medical conditions. • We will not board a dog with a terminal illness if the owner is not able to reach our home / veterinary surgery within 2 hours. We have experience of this ourselves. • Item 7 of our terms & conditions state <i>"I authorise Barkcation Babo to call a veterinary surgeon of my behalf in the case of an emergency whereby I cannot be contacted"</i>. 	<ul style="list-style-type: none"> • Inform the owner • Seek veterinary advise / care • Inform local authority
